COUNCIL REPORT

What an amazing journey we have had in 2018! We were blessed with Judy Zarubick's dynamic leadership as she served us as our Pastor for the first six months of the year. She continued her efforts to streamline our governance, become a more welcoming community, learn to appreciate fully the role of technology in enhancing worship, and prepare for the many changes facing the United Church of Canada as a whole, and Kincardine United in particular. Judy's partnership with a generous donor and volunteers from the congregation led to a complete transformation of the Offices, the Resource Centre and the Chapel. When the Search Committee report was presented, we were ready and able to welcome our new minister into our midst. Judy decided to retire as of June 30, 2018 but has continued to share her knowledge and skills with our congregation. Judy's leadership with the Audio-Visual Team has transformed our worship capacity; our heads are up as we sing joyfully together, following the words on the screens and absorbing the beautiful images that deepen our appreciation of the role of music in our worship experience. Judy will always have a special place in the hearts of our congregation.

And then came our "Holy Shift": we called the Reverend Gord Dunbar to be our full-time Minister of Sacrament, Word and Pastoral Care, effective July 1, 2018. Few of us will ever forget Gord's first service with us on July 2, when a neighbouring cat wandered in through the door and headed directly to Gord, who picked him up as we sang "O Canada", living proof of our need to welcome absolutely everyone into our community of faith. Gord's enthusiasm, hard work, caring presence, joyful music, dramatic presentations and sense of humour have shone brightly in our midst, encouraging us to "Colour Outside the Lines." He is leading us to work intentionally together to fulfill our Mission Statement, to listen to the Spirit as we discern how to move into the future with hope, joy, and confidence. As we move forward with our strategic planning exercise, seek ways to achieve the capital improvements needed for our church building, strive to appreciate our many strengths and build on them, we become a more open and welcoming community. We ask God's blessing on Gord's ministry with us.

As a congregation, we approved the Remits put forward by the 42nd General Council. All the Remits passed, with the exception of the Remit on One Order of Ministry. The 43rd General Council will meet in July to confirm the final results and decide on implementation of the changes. Work toward implementation has already begun. Presbyteries will be disbanded as of January 1, 2019; Regional Councils will replace Conferences and Presbyteries but will be very sparingly staffed so that communities of faith like ours will have added responsibilities to ensure accountability to the United Church. Your Council and Presbytery representatives will keep you informed of the changes as they are approved and implemented.

I am not seeking re-election as President and Council Chair. I will continue to serve as a Lay Worship Leader and a Presbytery Rep. until Presbytery ends and have been elected as a Commissioner to the 43rd General Council. Over my many years on Committees and Council, I have treasured the caring and diligent work done by KUC staff and volunteers and I know our congregation will continue to be well served by dedicated leaders. Over the past two years, as our family completed our final journey with our daughter, my colleagues on Council have gone out of their way to assist me and to fill in when I was unable to do so. They have my everlasting gratitude for their personal support and their faithful service to our community. Even in a time of sorrow and tribulation, I am constantly reminded, by this faith community and its leadership, that we are not alone. God is always with us. Thanks be to God.

- The room next to the elevator was cleaned out, painted and shelving put in
- Replacement of the floor in the downstairs washroom plus redecorate walls etc.
- Installation of display case at the back of the sanctuary
- The team continued its diligent work of looking after our property from fixing broken items, changing clocks, checking fire extinguishers, shoveling snow,
- Renovating the Chapel removal of all the items in the room, painting the room and putting up new blinds
- Arranged for food collected at KUC for the Food Bank be delivered each month
- Arranged for new office furniture as well as new "Resource Room" Furniture
- Painting of the Office and relocation of office furniture
- Preparation of written procedures required for the KUC manual

STEWARDSHIP PROGRAM

In 2017 Kincardine United Church launched its first Stewardship Program in several years. Letters were sent to members of the congregation thanking them for past support of time, talent and treasure and asking them to consider becoming more involved in those areas.

Membership and Mission made several donations throughout the year. PROGRAMME COMMITTEE

Throughout the past year Programme Committee has had the pleasure of working closely with Pastor Judy Zarubick, until the end of June 2017, and then the Rev. Gordon Dunbar, who joined us as our new full-time Minister of Worship on July 1st 2017. Along with David Hamilton, Minister of Music, these people have provided a carefully planned calendar of weekly worship services for Kincardine United Church. A few people have been required to provide Pulpit Supply during vacation and study leave, and their help is much appreciated.

During her time as Interim Supply Minister, Pastor Judy Zarubick worked with the Communications Ministry Team to purchase and install new equipment to facilitate screen projection during our worship services. This has been well received by the congregation and provides new dimension and flexibility during worship. A training workshop was provided for new volunteers interested in joining the audio- visual team. It is hoped that more volunteers will still come forward to join this small, dedicated group.

Supervision of the library in the Resource Room was transferred from Jack Tully to Mildred Clayton. Both these people have engaged in considerable organizing and up-dating work, for which we are very grateful. Members of the congregation are encouraged to visit this library and enjoy the interesting collection of books. There are some very comfortable chairs in the Resource Room now!

This year the Sunday School teachers decided to re-use some previous curriculum resources rather than buying all new. A roster of Sunday School teachers and Nursery workers has been maintained. New volunteers are always welcome in both these areas. It is a great pleasure to spend time with the youngest members of our congregation.

The House Teams and the Sacrament Guild have continued to faithfully fulfill their important tasks. New House Leaders and more volunteers are always most welcome.

Excellent Bible Study groups have been held in Fall and at Lent, and the Questers discussion group continues to meet on a monthly basis.

Wonderful music is regularly provided by David Hamilton, the choir, KUCIE, invited guest musicians and talented members of our congregation. Last September an excellent music workshop was provided for the choir and congregation by Dent Davidson. It is hoped that a similar event will take place this year, with an invitation extended to the broader community and a small fee charged.

Last but not least, the committee has enjoyed the opportunity to decorate the sanctuary for special worship events such as Christmas, Easter and Thanksgiving. The help of Property Committee members is always appreciated at these times, as well as the help of extra volunteers for the Christmas Eve Carol Service and the occasional drama productions, which highlight some special services.

The mandate of the Programme Committee encompasses the work of several Ministry Teams and numerous individual volunteers. All of their vital contributions are acknowledged and deeply appreciated.

SUNDAY SCHOOL REPORT

The Program Committee has responsibility for Sunday School to oversee the recruitment of S.S. teachers, approve curriculum material and develop standards appropriate for Christian Education. The Sunday School Ministry Team relates to the Program Committee. This team meets at least 4 times a year to schedule S.S. Teachers and discuss any programs or issues.

K.U.C. offers a S.S. program for children for approximately age three to teenagers on Sunday mornings at the same time as the worship service. The curriculum used is "One Room Sunday School" purchased from United Church Resource Distribution. This program teaches bible stories, has material for all ages groups and can be photocopied.

There are approximately 20 Sunday School age children in the congregation and attendance on any Sunday may range from 2 or 3 to 15 including visitors. During the year the children participated in dramas, intergenerational services and serving communion. The children are also active in Mission and Community services. 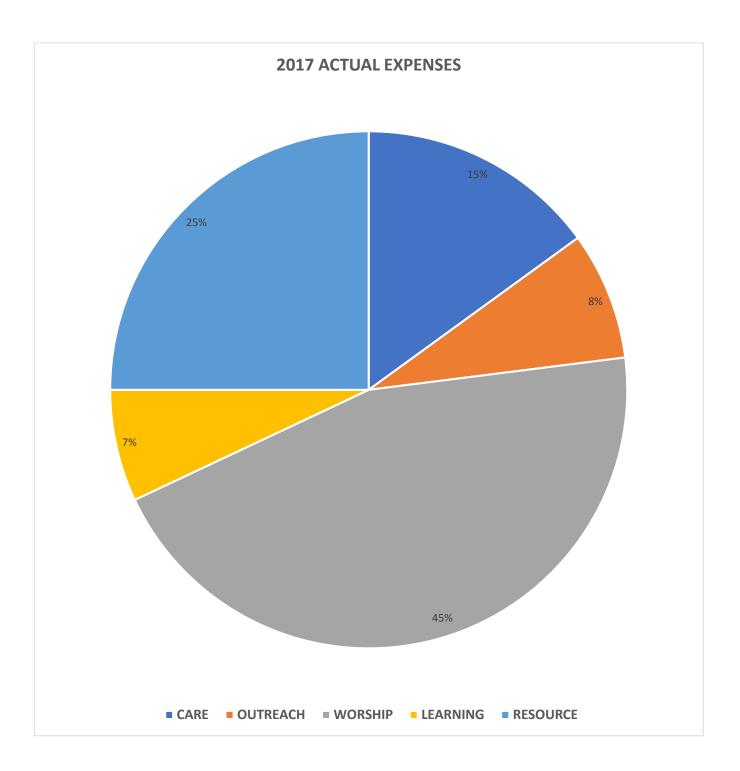

CONGREGATIONAL MEETINGS

KINCARDINE UNITED CHURCH CONGREGATIONAL MEETING Sunday, March 26, 2017

The congregation of Kincardine United Church was called to meet in the sanctuary on Sunday, March 26, 2017, after the morning worship service, to review and approve the Joint Search Committee report. Approximately 70 persons were in attendance.

Marion Boyd called the meeting to order at 11:30 AM, then introduced and turned the meeting over to John Van Berlo, a Bruce Presbytery representative from the Pastoral Relations committee.

John Van Berlo opened the meeting with a brief prayer, and explained that the meeting was to receive the report of the Kincardine United Church Joint Search Committee. John said that members would be allowed to vote on the report, but not adherents, and if there were any questions with respect to membership status the historic roll was available for consultation. John then turned over the meeting to Gregg McClelland, a member of the Search Committee.

Gregg McClelland introduced the members of the Joint Search Committee: Liz Dillman (chair), Sheila Bauer, Angela Hazlewood, Charles Ludlow, Marilyn Meldrum, Teresa Perfrement, & Berndt Portz, as well as Charles Clarke & Rev. Herb Klaehn (presbytery representatives). He then read a summary of the ministry personnel candidate prepared by Liz Dillman, adding some of his own observations from the search & interview process. Gregg said the recommendation, by unanimous decision of the Search Committee, was that Rev Gord Dunbar be called as minister of Kincardine United Church, and went on to state the terms.

Moved by Gregg McClelland, seconded by Teresa Perfrement, that Kincardine United Church approves and seeks the approval of Bruce Presbytery for the call of Rev. Gord Dunbar OM as minister of Word, Sacrament & Pastoral Care with the following terms:

- Start date: July 1, 2017
- Salary and Housing: \$67,438 per annum (Category F)
- Vacation: One month per annum including 5 Sundays
- Study Leave: 3 weeks per annum including 3 Sundays
- Telephone: \$100 per month
- Continuing Education: \$1,500 per annum
- Office Assistance: 14 hours per week
- Mileage: 39¢/km.
- Moving expenses: \$4,000 upon presentation of receipts.

John Van Berlo asked if there were any questions related to the motion to accept the Search Committee's report.

Barrie Schmidt asked if there was any intent of reviving youth in the congregation. Gregg McClelland said that Gord had lots of experience dealing with youth and would be willing to take on this challenge. He said that Gord presently averages 15 visits weekly, is enthusiastic, and enjoys working with youth.

Teresa Perfrement noted that Gord Dunbar had read the Kincardine United Church JNAC report fully and had only applied for the position at Kincardine.

David Hamilton said that he was encouraged by the search committee's report and would support the motion to hire the candidate, although he was not entitled to vote.

Fran Gannet asked if there was any housing allowance, to which John Van Berlo said that housing allowance is now part of the minister's salary per United Church of Canada rules.

Dotty McClelland asked if any of Gord's family would be coming with him, to which Gregg McClelland said there was no information to share in this regard.

Mary Ann Knowles asked how old Gord was, the response being that this is not a question permitted to be asked.

Judy Zarubick asked for reconfirmation of the travel allowance, which Gregg stated as 39¢/km. John Van Berlo noted that this is the expected cost of operating a vehicle and changes from year to year.

There being no further questions raised, John Van Berlo called for a vote on the motion, with paper ballots being distributed and collected. John then left the meeting to count ballots with adherent Rad Michelson, adherent, acting as scrutineer.

While the ballots were being counted, Marion Boyd said that the recommendation of the Search Committee would be forwarded to the presbytery Pastoral Relations committee, then to the next presbytery meeting (April 18th at Kincardine). Marion noted that the ballot process was being used since experience elsewhere in Bruce Presbytery has been that some people are uncomfortable expressing a dissenting vote in a public manner (by show of hands).

John Van Berlo returned to the meeting and announced that 59 ballots were cast and the decision was unanimous in favour of the motion, declaring the motion to be carried.

Marion Boyd thanked John Van Berlo for his assistance at today's meeting. She went on to thank Judy Zarubick for being the minister during the period while the Search Committee conducted its work. Bette Tusz expressed her thanks to the leadership of the congregation, and especially to Marion Boyd, for the JNAC work which led to this outcome by the Search Committee.

Its purpose having been completed, Marion Boyd declared the meeting ended at 12:07 AM

5. Business Arising from the Minutes (Marion Boyd)

Marion Boyd said there was very little business arising from the previous minutes, other than changes to our organizational handbook structure. She said that we are in the middle of this work, which will bring us up to date with respect to aligning the handbook with our current structure.

6. In Memoriam (Judy Zarubick)

Judy Zarubick said that we remember those for whom death has meant that they have returned to God and are now held in God's hand. She then read the names of those recorded in the In Memoriam list in the 2016 Annual Report.

7. <u>2016 Financial Report and Revised Budget for 2017</u> (Donna Mowry)

Donna Mowry said that the 2017 budget had been approved at the December 11th meeting, but since that meeting there have been two new items added. Referencing the Administration budget (page 25 of the annual report), she noted that line items 5 & 6 have been added for the \$25,000 line of credit loan and interest payments as the monies borrowed in 2016 have not been repaid, so it was felt this needed to be added and highlighted in the budget.

Moved by: Donna Mowry

Seconded by: Liz Dillman

That the 2017 budget be approved as amended.

CARRIED

Marion Boyd declared that the revised budget for 2017 had been accepted.

Donna Mowry went on to say that after removing the interest and outstanding loan, the 2017 Administration budget is similar to 2016, and excluding the loan puts the total budget at about \$237,000, which is less than the 2016 budget.

Donna said that in 2016 salaries were about 67% of the budget, and operating expenses (heating, insurance, etc.) accounted for about 25%, leaving little discretionay spending. The budget has remained about the same for the past several years. Donna noted that the new minister's budget includes \$5,000 for moving expenses as well as expenses for a new computer (if required). Donna said the Programme budget is very much like 2016, but there had been additional unexpected expenses for the organ which made it higher, and the M&M budget is also similar to the previous year.

Quoting from December 11th meeting minutes, Donna noted that it was hoped that monthly donations would be \$17,000, but with monthly givings for 2016 averaging \$12,000-\$13,000 this resulted in a deficit of \$20,432. Donna said we need to find a way to supplement this shortfall, and a fundraising team is being organized to come up with projects which might address the shortfall.

Mary Phillips asked about the funding source for the sanctuary projection system, to which Donna said the funding arose from a bequest which had gone into the General Fund with the balance of the bequest remaining as yet unallocated.

Shirley Marie Harris noted that the 2007 M&S target had already been approved at the December 11th congregational meeting.

9. 2016 Written Annual Reports

11. Other Business

a) Report from Bruce Presbytery (Rod Coates)

Rod Coates provide some highlights of Bruce Presbytery items, including the following:

- The M&S donations provided by Kincardine United Church during the past two years are more than any other pastoral charge in Bruce Presbytery, and represent approximately 10% of all M&S givings in the presbytery.
- 2. Working with Bruce presbytery is both a great joy and a learning experience with respect to how other communities of faith are dealing with issues. Kincardine United is blessed about 1/3 of presbytery pastoral charges (28 in total) are in Search or Joint Needs Assessment Committee (JNAC) processes. Kincardine was very fortunate to have good presbytery support for both our JNAC and search processes.
- 3. Three presbytery representatives Emily Perry, Marion Boyd & Rod serve on the presbytery executive.
- 4. For the past year a large portion of presbytery's agenda has been consumed by debate on remits. Bruce Presbytery has now completed 7 of 8 remits, with all those requiring presbytery response (3 in total) completed by the February 17th deadline, and these have all been approved by a wide majority of the 88 presbyteries. In July we will learn whether or not Remit

1, the 3-Council model, has been approved and then we will begin the work of transition to the new structure, which does not include presbyteries.

5. Bruce Presbytery will be the host for the annual Hamilton Conference annual meeting at the Unifor Centre in Port Elgin the last weekend in May. Our new minister, Gord Dunbar, will be chairing the meeting and relinquishing his role to a new Conference President. In consideration of the Annual Meeting, and the two learning day workshops sponsored by presbytery last fall, there will be no Learning Day workshop this spring as in other years.

b) Bruce Presbytery Day of Action (Marion Boyd)

Marion Boyd said that due to the ministerial support situation, Bruce Presbytery has agreed to a day of action to address this. She mentioned that Bruce United Co-op will come to an end in June 2017, which will create three new JNAC's. She said that as presbyteries do the work of attracting and supporting ministers, if they come to an end then this process will become that much more difficult.

At last week's presbytery meeting, presbytery agreed to a tentative May 9th meeting date at Clifford to deal with the growing problem of not being able to fill our ministry positions. Marion noted that at Kincardine United we have gone from two full time minister positions (in the recent past) down to one full time minister. Presbytery is looking for a facilitator to help with the meeting, and all congregations are invited to send representatives.

Shirley Marie Harris commented that she had served on presbytery in other areas, and wanted to commend and thank the reps we have at Kincardine United. She went on to say that Mary Phillips is taking over her role as Mission Enthusiast.

Marion Boyd noted that Rod Coates would be assuming the roll of Bruce Presbytery chair this year, effective June 2017.

12. Recommendation for the Date, Place & Format for 2017 Annual Meeting and Budget Presentation

Marion Boyd asked for a response regarding the format for 2017 annual meeting, with the consensus being that the format for the 2016 annual meeting worked well for us. **Moved by:** Stu Mowry **Seconded by:** Mary Phillips

2018 BUDGET CONGREGATIONAL MEETING SUNDAY, DECEMBER 17, 2017

The congregation of Kincardine United Church was called to meet in the sanctuary on Sunday, December 17, 2017, following the morning worship service, to approve the 2018 budget. Approximately 60 persons were in attendance.

14. Call to Order and Constitution of the Meeting

Marion Boyd called the meeting to order at 11:35 AM, stating that notice of the meeting had been duly given for the sole purpose of reviewing and approving the 2017 budget.

15. Opening Prayer

Gord Dunbar opened the meeting with a prayer.

16. Behavioural Covenant

Those present read the Kincardine United Church Behavioural Covenant.

17. Enabling Motions

Charles Clark presented the enabling motions.

- f) That all adherents be made Corresponding Members with privileges to vote.
- g) That Marion Boyd chair the 2018 budget meeting.
- h) That Rod Coates act as recording secretary for the 2018 budget meeting

CARRIED

18. 2017 Financial Report and Budget for 2018

Donna Mowry referenced the last page of the proposed 2018 budget, which showed the total budget of \$259,701 for 2017 compared with \$264,200 for 2018. She said that the \$4,498 increase over last year represented a 1.7% increase, which is just about the cost of living for 2017. Donna said that the total budget for Administration was just over \$96,000 in 2017, and is now just over \$68,000 for 2018. She said that the decrease was mainly due to elimination of the \$25,000 line of credit loan (with Nesbitt Burns), which does not exist in 2018. The Search Committee \$2,000 budget is also not required in 2018.

Continuing with other budget highlights, Donna noted that the 2018 M&P budget is \$4500 more than last year and that other committee increases are offset by the Administration budget reduction. Referring to the first page summary, Donna stated that:

- Staff salaries are 65% of the budget
- Administration is 26% of the budget, representing operating expenses of the church.
- 91% of the budget is the cost of running the church (salaries and operating expenses)
- The narrative budget, created by Liz Dillman, lists categories of Care, Outreach, Worship, Learning, and Resource.

- Under the M&P budget, the minister's salary in 2017 was \$33,720 but in 2018 is \$68,382 since it represents a full year's salary.

Moved by: Donna Mowry Seconded by: Liz Dillman

That the 2018 budget be approved as presented.

CARRIED

Marion Boyd noted that it is important to consider this budget seriously since it reflects our church's work and mission in the community. Marion requested that Gord Dunbar and David Hamilton, the staff members present, excuse themselves at this point of the meeting so that any salary questions could be addressed.

Barry Schmidt stated that he felt one item was missing, which was budgeted revenue. Barry said that revenue as of the end of November was \$172,000, and that by adding normal December extra donations it extrapolated to a year-end figure of \$198,000; this revenue pattern, if continued into 2018, would result in a deficit projection of \$68,000. Barry said that continuing deficits are a serious problem. He said that we sold investments to offset the deficit in 2017, and if this is a continuing trend the investments will be significantly depleted. He recommended that we remove the items of Choir Workshop and Intern Minister to reduce our costs for 2018.

Moved by: Barrie Schmidt

Seconded by: Joan Gillespie

That we remove the Choir Workshop and Intern Minister items from the 2018 budget.

DEFEATED

Donna Mowry said that the stewardship campaign would increase revenue for 2018 and hopefully address some of the revenue shortfall. Rod Coates noted that PAR (Pre-Authorized Remittance) changes resulting from the stewardship campaign to date have resulted in a projected General Fund increase of \$5,000 for 2018.

Randy Norris noted that people underspent "remarkably" in 2017, so there is some offset of the deficit due to the reduced committee spending.

Bernd Portz asked why the 2018 mileage rate has increased to \$5,000. Marion Boyd said that Don Harry never submitted mileage claims and Gord Dunbar's contract includes compensation for mileage. Donna Mowry said that Gord is already conducting additional pastoral visiting, including hospital visits to London and Guelph.

Randy Norris noted that a large component of the payroll expenses were mandatory payroll deductions.

Rad Michielson & Dotty McClelland both noted that offsetting revenue and costs were to be expected from choir registration for the September choir workshop. Rad Michielson explained some of the benefits of the choir workshop and how it added to the choir's ability to express itself. Liz Dillman said that there would be offsetting revenue for a grant for the intern minister. Marion Body noted that the 2016 JNAC approved the inclusion of an intern minister, and that – if an intern minister were available - the cost would be an 8-month commitment over 2018 and 2019.

Donna Mowry asked Mary Phillips to comment on the staff salaries. Mary Phillips summarized the information as follows:

- 1.4% increase for the Minister of Word & Sacrament based on national UCC guidelines
- 1.4% for the minister of music based on RCCO (Royal College of Church Organist) guidelines
- Office coordinator & custodian salaries based on the Grey-Bruce living wage for 2017, which increased significantly. It would have resulted in 9% increase, so M&P recommended 4.5% this year and will recommend a 4.5% increase again next year.

Ron Harris said that we need to think about the future. He said that we cashed in a \$25,000 investment to pay off our line of credit loan. He said that if this trend continues for 5 years there will be no investments left. Ron said that we will shortly need a new roof, and hopefully this money will come from somewhere, but we need to think about that.

Marion Boyd thanked Ron for his comments, noting that we are in a similar situation to other churches in the presbytery. She said that Council requested Bruce Presbytery to release the manse funds for this purpose, and that Council is thinking that we need to have a capital fund in addition to the operating fund. She said that Barrie & Ron are only identifying what our financial situation is. Stu Mowry said he shared Barrie & Ron's concerns, as a trustee, and that we need to have money in place in the General Fund and make sure that we provide a focus for this, recognizing that we have donations for wish list items but also need to face reality.

Charles Clark said that he had participated in needs and search committees of Kincardine United, although he is not yet a member. He said he was concerned about a church that is afraid to move ahead, that money is there and he expects that there will be new people attending as a result of the new minister. Charles said we should enter into prayer more often and enter into the hope that we will move ahead.

Randy Norris said that it's a matter of "bums on seats", and related a conversation he had about signage as a way to attract more people into the church. He said there are more important things to worry about first – i.e., keeping the rain out with a new roof.

Marion Boyd said that the trustees who spoke are exercising their fiduciary responsibility by identifying financial concerns. She went on to say that Council believes that there is a new vitality in the congregation, that fixing the roof should be considered as an investment, and that no decision has been made to address this funding.

Following the approval of the budget, Marion Boyd requested that Gord Dunbar and David Hamilton, be invited to return to the meeting.

19. 2018 Mission & Service Target

Mary Phillips presented the M&S target for 2018. <u>Moved by</u>: Mary Phillips <u>Seconded by</u>: Krista Ritchie That the 2018 M&S objective be \$28,500.

CARRIED

20. Recommendation for the Date, Place & Format for 2017 Annual Meeting

Marion Boyd said the 2017 Annual Meeting was set for April 15th, 2018, but we have a new minister with a vacation on that date. Marion said that we wish to move the meeting by one week to April 22nd.

Moved by Donna Mowry Seconded by Rad Michielson That the annual meeting be held April 22nd, 2018.

CARRIED

21. Other Business

No other business was raised.

22. Adjournment and Prayers

There being no further business, Marion Boyd declared the meeting closed at 12:30 PM. Gord Dunbar closed the meeting with prayer.
