The Council of Kincardine United Church was called to meet on Tuesday March 4th, 2025, at 7:00 p.m. via Zoom. Notice of this meeting was given eight days prior to the meeting via an e-mail by the secretary. A second e-mail was sent out letting Council members know that all the documents had been added to the shared drive.

Judy Zarubick called the meeting to order at 7:08 p.m. and welcomed Council.

1. Welcome and Constitution of Meeting (Judy Zarubick)

Miigwich! Thank You!"

3. Lighting of the Candle (Judy Zarubick)

Judy Zarubick led Council in prayer: "We light this virtual candle as a sign of God's Spirit at work in the world, in our community, and in our on-line gathering this evening. May we feel God's spirit surround as we look into the candlelight. Amen".

4. Devotion (Judy Zarubick)

Judy Zarubick read from: Matthew 6:16-18a and "Act Fast" page 2 "Pancake Supper Sacrifices" which is about choices we make and the power we have together to make a difference in the world. Judy Zarubick went on to ask Council members what they might be giving up for Lent. Council members took turns sharing what they may or may not give up! Judy Zarubick finished the devotion by leading Council in prayer.

7. Business Arising

i) Regional Requirements/Search Committee

Judy Zarubick stated that she has updated the fiscal worksheets for the ChurchHub as well as the team profile for the Candidate for twenty-five hours (which is thirty hours-Judy Zarubick has five hours out of the thirty hours). Judy Zarubick also stated that the Region has to approve her re-appointment. Judy Zarubick went on to say that the search committee has lots of work to do to find a Candidate that will complement their goals with Kincardine United Church's goals. However, Judy Zarubick feels that the team profile on the ChurchHub is generic enough that a suitable Candidate should be found. After the Candidate is matched with Kincardine United Church, a Community of Faith Connection (COFC) will need to be established which essentially is a group of people who will support the Candidate with their learning goals and meet monthly. The COFC does not take away the duties of the Ministry and Personnel committee in any way. Judy Zarubick went on to state that a Liaison from the Region will need to be provided to Kincardine United Church to support with the process of the search. On March 11th, on-line tool kits/training will be offered through the Western Ontario Waterways (WOW) Region. Judy Zarubick will find out exactly where the training will be found on the website and share with the search committee members.

After a fulsome discussion about creating a search committee, it was decided to appoint three people to a search committee and more could be appointed as necessary when volunteers are found.

Council to appoint Sheila Bauer, Liz Dillman, and Art Wiebe to Kincardine United Church's search committee.

Judy Zarubick declared these appointments approved by consensus.

ii) Committee Members for 2025

Judy Zarubick provided a list to Council members of all committee members for 2025. Angela Hazlewood will be adding the list to the shared drive.

It was discussed to add a write-up to the church announcements about the committees which need more members specifically the Programme and Administration committees.
