- 6. Food box sponsorship email from Shirley Bieman Motion by Lou Anne Dudman that we send \$40 to the good food box for the Syrian Family for the upcoming period taking us to February, seconded by Melinda Smegal, carried. In the new year we will continue

to provide the two boxes, but there may be a price increase to address, so we have just done the two months.

- 7. A heads up: UCW talks may be forthcoming regarding whether it is necessary for UCW "units" and "General" to have executives and treasurers. It may be possible to have a UCW line in our budget with an "IN" for givings and an "OUT" for their disbursements? This is just a heads up for us as it has not been a full discussion, but the feeling from M and M is that we can likely accommodate this.
- 8. LEGO league use of church. Due to the vulnerable sector involved in this age group it was felt by M and M that should the group require a meeting place, they need to go through the usual channels. Currently the church's insurance may not cover outside groups, so they would need their own.
